Liquidity Tokens

Release: 100% of liquidity tokens are released at the Token Generation Event (TGE) to ensure immediate liquidity for trading on exchanges.

Lock Period: These tokens are then locked for a duration of 3 years, preventing any premature injections of liquidity that could disrupt market dynamics. This lock period helps stabilize the market and fosters a long-term, sustainable growth trajectory for the token.


