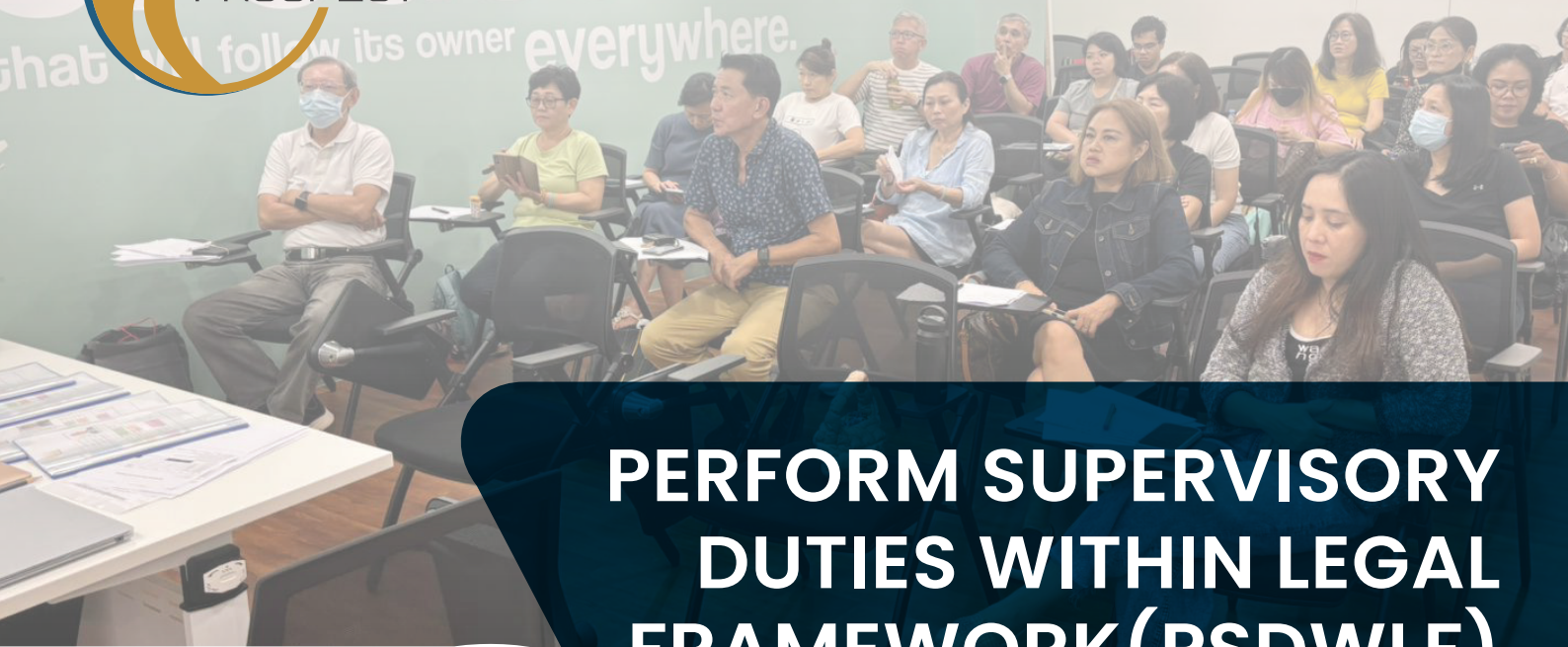

INTRODUCTION
