INTRODUCTION

Prospect Protection's **Deterrence (Perform Security Duties at Protected Areas and Protected Places)** course covers the knowledge, skills and attitudes required of a security personnel to perform security duties, such as access control duties, at protected areas and protected places. Learners will also be able to attain knowledge and capabilities to identify and manage security incidents involving suspicious activities, vehicles or intelligence gathering efficiently and effectively at protected areas and protected places.
